

UCC Written Form Acceptance

November 10, 2016 Update

The chart below clarifies the current acceptance/rejection practices of state filing offices for the new (04/20/11 revision) and old (any form with a revision date before 2011) UCC written forms. It also indicates whether the state has approved its own UCC forms in addition to those set forth in UCC § 9-521.
