AL	S252	2/28/17	Enacts the 2014 Uniform Voidable Transactions Act.	FAILED. Did not pass out of committee before legislature adjourned.
AR	H2139	3/6/17	Enacts the 2014 Uniform Voidable Transactions Act.	ENACTED on 4/7/17. Takes effect 91 days after the legislature adjourns.
AR	H2249	3/6/17	Enacts the 2014 Uniform Voidable Transactions Act.	FAILED. Withdrawn by author on 3/10/17.
CT	S1021	3/14/17	Provides that undergraduate tuition payments made to institutions of higher education are not construed as fraudulent transfers under the Uniform Fraudulent Transfer Act.	ENACTED 6/13/17. Takes effect 10/1/17.
IN	S316	1/9/17	Enacts 2014 Uniform Voidable Transactions Act. Amended to delete UVTA Section 3(c).	ENACTED on 4/13/17. Takes effect 7/1/17.
FL	H1159	3/7/17	Enacts 2014 Uniform Voidable Transactions Act.	FAILED. Died in committee on 5/8/17.
FL	S1566	3/7/17	Enacts 2014 Uniform Voidable Transactions Act.	FAILED. Died in committee on 5/8/17.
MA	H46	3/16/17	Enacts 2014 Uniform Voidable Transactions Act.	Pending.
MI	S982	5/24/16	Enacts 2014 Uniform Voidable Transactions Act.	ENACTED 1/6/17. Takes effect on 4/6/17.

NJ	A3742	5/12/16	Enacts 2014 Uniform Voidable Transactions Act.	Carryover from 2016. Pending in Assembly (Passed Judiciary Committee on 6/6/16).
NY	A1853	1/13/17	Enacts 2014 Uniform Voidable Transactions Act.	Passed Assembly on 6/15/17. Pending in Senate.
NY	S6180	5/11/17	Enacts 2014 Uniform Voidable Transactions Act.	Passed Senate Judiciary Committee on 5/23/17.
PA	S629	4/18/17	Enacts 2014 Uniform Voidable Transactions Act.	Passed the Banking and Insurance Committee 6/13/17.
RI	H6123	4/14/17	Enacts 2014 Uniform Voidable Transactions Act.	Assigned to House Corporations Committee.

VT	H35	1/11/17	Enacts 2014 Uniform Voidable Transactions Act.	ENACTED 5/4/17. Takes effect on 7/1/17.
WA	S5085	1/12/17	Adopts the Uniform Voidable Transactions Act.	ENACTED on 4/19/17. Takes effect 90 days after legislature adjourns.
