| State | Bill | Introduced | Description | Status |

| Alabama | H233 | 2/13/20 | Amends the Alabama Uniform Electronic Transactions Act to allow a municipality to use electronic records and signatures in the conduct of its affairs | Passed House County and Municipal Government Committee 2/13/20. |
| California | A513 | 2/13/19 | Amends the state's Uniform Voidable Transactions Act (UVTA). Under current law, for purposes of the UVTA an individual is located at the individual's principal residence. This bill would provide that an individual is located at the individual's principal residence or domicile. | Assigned to Assembly Judiciary Committee. Carry over to 2020. |
| Illinois | H3323 | 2/15/19 | Adopts the Uniform Dental Electronic Transactions Act. | Passed House Insurance Committee 3/26/19. |
| Massachusetts | H57 | 2/22/19 | Amends UCC Articles 3 and 4. The bill would clarify existing rules for lost negotiable instruments and how a maker of a negotiable note obtains a discharge on payments when the note has been sold. It also removes various barriers to electronic commerce. | Assigned to Joint Financial Services Committee. |
| Massachusetts | H58 | 2/22/19 | Adopts 2014 Uniform Voidable Transactions Act. | Assigned to Joint Financial Services Committee. |
| New Jersey | A3384 | 2/24/20 | Enacts 2014 Uniform Voidable Transactions Act. | Assigned to Assembly Financial Institutions and Insurance Committee. |

| South Carolina | S262 | 1/8/19 | Enacts 2014 Uniform Voidable Transactions Act. | Assigned to the Senate Judiciary Committee. Carry over to 2020. |
| United States | S2755 | 4/25/18 | Allows the US Postal Service to offer basic financial services and makes the USPS subject to the provisions of UCC Article 4. | Assigned to the Senate Homeland Security and Government Affairs Committee. |
| Washington | S6028 | 1/13/20 | Adopts the Uniform Electronic Transactions Act. Substitute bill on 1/16/20 added Blockchain and Distributed Ledger Technology references. | ENACTED 3/18/20. Takes effect 90 days after adjournment. |
| Wisconsin | A719 | 1/8/20 | Adopts the Uniform Voidable Transactions Act. | Passed Assembly 2/18/20. Assigned to Senate Insurance, Financial Services, Government Oversight and Courts Committee. |
| Wisconsin | S643 | 1/8/20 | Adopts the Uniform Voidable Transactions Act. | Assigned to Senate Insurance, Financial Services, Government Oversight and Courts Committee. |
