Features



Entity summary

CSC Entity Management provides an entity summary details page that includes the basic core entity data that flows in automatically in conjunction with CSC's Registered Agent and Global Subsidiary Management (GSM) services. The data is updated for you when CSC handles your corporate transactions. The entity details page can be tailored with custom fields and additional categories of information. Fields can easily be assigned to all entities or a subset of entities via a custom layouts feature.



Reporting

CSC Entity Management gives users the option to use standard, formal board-ready reports with more than 30 standard report templates, and features an ad-hoc reporting module where organizations can design and save their own report templates. CSC can also build custom report templates through our Professional Services Team.



Corporate tracker

CSC's Corporate Tracker service monitors your entities' secretary of state statuses and good standing. Our tool tracks and manages delinquencies, administrative dissolutions, revocations and other changes to your entities' statuses and reports them directly to you via email alerts, giving you the early warning you need for timely resolution. The solution identifies the type of change, creates a before and after snapshot of the entity in question, and displays an "as of date" for each status update.



Entity API

CSC Entity Management features a secure application programming interface (API) that establishes a framework for integrating data and documents stored in CSC Entity Management with one or multiple internal enterprise or third-party applications.



Calendar module

Includes compliance tracking tools like the Good Standing Calendar, DBA Calendar, and My Calendar. CSC's Good Standing Calendar automatically creates annual compliance events for U.S. entities, and for international entities that use CSC's GSM service. Event status is automatically updated when CSC handles your compliance filings. Clients also have the flexibility to add custom compliance events to the calendar.



Beneficial ownership visualization

CSC Entity Management provides a secure, structured approach to tracking information required in Financial Crimes Enforcement Network (FinCEN) beneficial ownership reports (BOIR) as set forth in the Corporate Transparency Act (CTA). The Beneficial Ownership Visualization Report aggregates the company's entity data, owners, owning entities, and appointment information for owning entities, as well as CTA-related compliance information such as CTA classifications, FinCEN IDs, and individual taxpayer identification numbers (ITINs), providing unparalleled transparency to owners and individuals with appointments across ownership structures. Configurable grids make capturing, viewing, editing, and exporting reporting information easy.



Global heat map

Our technology platform provides transparency into entity data, documents, structure charts, compliance events—and brings newfound clarity to your geographic footprint with the interactive heat map feature. The map provides a visualization of where your entities are around the world, allowing users to zoom in on specific regions, drill down to country, state, and providence levels. With customizable options to depict both active and inactive entities, the map shows at a glance the volume of your entities by jurisdiction. The convenient search feature within the map locates any entity in your portfolio in real time.



Officers and directors

CSC Entity Management lets you easily create and apply standard slates of officers and directors across any number of entities and create unlimited titles for officers, directors, members, managers, partners, powers of attorney, committee members, and other custom capacities. You can also maintain current and historical officer and director titles and terms and re-elect an entire slate of officers or directors within an entity. Workday integration

CSC provides powerful transparency around changes in your Workday® HR system that impact the officer and director records maintained in CSC Entity Management through a direct, pre-built integration. This secure integration connects employee records stored within Workday with the legal entity data housed in CSC Entity Management to improve the accuracy of your director and officer records and shorten the process of making necessary updates when changes occur. Data changes that can be tracked using this integration include name, employee status, job title, business title, company name, location, and region. Secured roles and permissions as well as configurable notification features ensure that only appropriate users are granted access to view these sensitive changes.



Searching

CSC Entity Management's powerful search features allow your organization to search across any of your entity data within your portfolio. This includes any entity-related data, such as entity name, jurisdiction, entity status, officer or director names and titles, etc. In addition, CSC's full-text document searching capability lets you search for documents containing a specific word or phrase. With this capability, you can easily locate any document where a reference to a specific activity, officer name, or other detail is contained within the text. CSC Entity Management automatically applies an Optical Character Recognition (OCR) layer to PDF documents that are uploaded into the Minute Books and Other Documents sections, ensuring that these documents are fully text searchable upon upload.



Section 16 Filing

CSC's secure, SaaS-based, Section 16 filing solution is available as part of CSC Entity Management, and allows users to create, manage, and file Section 16 documents for insiders and reporting owners. In just minutes, you can create, preview, and transmit Electronic Data Gathering, Analysis, and Retrieval system (EDGAR) formatted forms 3, 4, and 5 directly to the U.S. Securities and Exchange Commission (SEC). You have the ability to prepare draft filings in advance, and test file or live file directly with the SEC. The solution also includes the ability to file for multiple reporting owners in the same filing, and maintain footnote libraries for quick access to commonly used footnotes. Filing acceptance messages are available immediately and emailed to you after a filing is placed.



Stock and ownership

CSC Entity Management allows you to track your current and historical stock and ownership details and enables you to retrieve and report on any point-in-time data elements. Users can create an unlimited number of custom fields in the capital, ownership, and ownership transactions sections.



Document management and electronic minute books

Built on OpenText™ Documentum, our document management system enables easier handling and safer storage for all your vital corporate records in more than 200 document formats. Beyond storage capabilities, you'll have the functions to generate documents and route them for signature electronically all while working within the platform. The system is role based, giving your administrator(s) total control over viewing and editing access. CSC Entity Management enables you to assign minute books to a particular entity, create the most relevant folder structure, and attach minute books or any other documents to a particular entity or create portfolio-wide folders. In addition to the documents that automatically flow into the platform via filings that CSC performs, documents can also be efficiently imported via the drag and drop function, and administrators can restrict user access via a folder level security feature. The CSC Entity API can be leveraged to create an ongoing, secure feed of documents into your internal or third-party document management system.



Organization charts

CSC Entity Management makes visualization of your organization easy, giving you the ability to create organization charts based on ownership data. Users can include specific criteria (such as ownership at any historical point-in-time), add entity-related attributes to the display, create complex formatting rules with shapes and a complete color palette, and export and share your organization charts. Advanced charting features include the ability to create sub-charts, enabling organizations to intentionally split larger charts into multiple pages, including on-screen manipulation to control the precise positioning of each entity, and an org chart legend feature to clearly explain the meaning of each formatting rule.

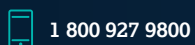
